2. Last date for receipt of the application is **21 days** from the date of publication of advertisement in the Employment News / Nai Duniya. This hospital will not be responsible for any postal delay. Application by hand will not be accepted.
3. The date for determining the age limit shall be the closing date for receipt of application.
4. One self addressed envelope 12 cm X 27 cm size duly affixed postage stamps of Rs. 25/- on the top corner of the envelope and self attested photocopies of following documents/certificates to be attached alongwith application :-
(i) Education qualification certificate.
(ii) Date of birth certificate.
(iii) Caste certificate where applicable.
(iv) Experience certificate where applicable.
(v) Income & Assest Certificate for EWS candidates.

9. Candidates will bring original certificates in support of age, caste, qualification, experience etc., on the date of test.
